Introduction

With more than six Crores people and population density of 308 per sq. km. Gujarat has a vision and commitment to provide effective and quality health care to all with special focus on reaching the unreached and serve the underserved. One of the highest priority goals of Department of Health & Family Welfare is to make the health system of Gujarat more available, accessible, accountable, equitable, transparent and cost effective.

The objective is to reduce the MMR, IMR, Address adverse sex ratio, combat malnutrition with multi pronged strategy, effectively implement NHM programmes provide state of art health and medical education. Also it aims to provide free Quality drugs and modern Diagnostic facility at door step and enabling information and Communication Technology as a strategic resource, making it an integral part of Health Governance.

With the expansion of health care network in the state and increasing budgetary provisions, CMSO was transformed into Gujarat Medical Services Corporation, as per GR MSP/102012/58/G dated on 20 July 2012 as an autonomous body, to ensure timely procurement & distribution of drugs and medical equipment for all the State Health Institutions.

With the changes in the healthcare arena there was a felt need of developing new as well as upgrading the existing functioning and processes of CMSO, and consequently develop an institution supported with necessary infrastructure to make the system responsive to meet the objectives of the universal health coverage.

With the view to match the changing demands and pace of development in the sector, CMSO was transformed into **“Gujarat Medical Services Corporation Limited”** (GMSCL) as an autonomous body and was incorporated under companies act, for systematic procurement, inventory management, Management information system and to infuse professional management with establishment, development and strengthening the use of information technology in medical store organization.

GMSCL was established primarily to look after the procurement and supply of medicines and other hospital requisites for the government health care facilities in the state. The working of HMSCL during the first 3 years of its existence was studied and critically analyzed in the study. The situation prior to the establishment of HMSCL for a period of Four years was also studied and evaluated.

The study finds that HMSCL could improve access to medicines in the state during the study period. The quality and availability of medicines in government hospitals also increased considerably. HMSCL could introduce many innovations in its functioning and make the procurement scientific and transparent. Preparation of Essential drug list, modernization of warehouses is other progressive steps of HMSCL. The utilization of information technology in a unique manner helped to bring transparency in functioning and reduce unethical practices remarkably. It also helped to make its services fast in many aspects.

The Corporation deserves more support and encouragement from the State and Central Governments and other organizations. HMSCL also establish a market intelligence wing for conducting studies and evaluate its functioning, programmes, policies and other related activities that will further strengthen its functioning. The manner in which HMSCL is improving its functioning in the four years of its origin shows that the Gujarat model of Drug Policy is one of the best policies among all Indian states.

The Central Medical Stores Organization (C.M.S.O) was established in 1978 under Health and Family Welfare Department. Govt. of Gujarat and was entrusted with the functions of procurement, storage, distribution of medicines surgical goods medical equipment / instrument and insecticides for the health care institutions under Govt. of Gujarat.

With the changes in the healthcare arena there was a felt need of developing new as well as upgrading the existing functioning and processes of CMSO, and consequently develop an institution supported with necessary infrastructure to make the system responsive to meet the objectives of the universal health coverage. Objectives:-

To buy, sell, supply, store, maintain or otherwise deal in all kinds and varieties of generic and patent / non-patent medicines, drugs, mixtures, formulations, tablets, pills, powders, pharmaceuticals and medical products, needles, syringes, injectable, vaccines, sera, immunogens, phylacogens, chemicals and surgical dressing, kits and instruments and to takeover / establish/ operate and maintain diagnosis centers.

To take up hospitals, nursing homes and healthcare centers and provide, encourage, initiate or promote facilities for the development of new methods of diagnosis, understanding and prevention and treatment of diseases and to undertake designing and construction of Hospitals and / or other buildings for Government, or for any other person including local authorities, corporations, societies, trusts, companies, firms and other persons.

To act as nodal agency for Government of Gujarat to implement any scheme and programs as may be assigned or transferred by the Government of Gujarat, and also any scheme / program of Government of India, WHO, UNICEF, or any other regional, national, international or bilateral agencies in the health and family welfare sector.

Computer Branch – Computerization of G.M.S.C.L and Planning of G.M.S.C.L

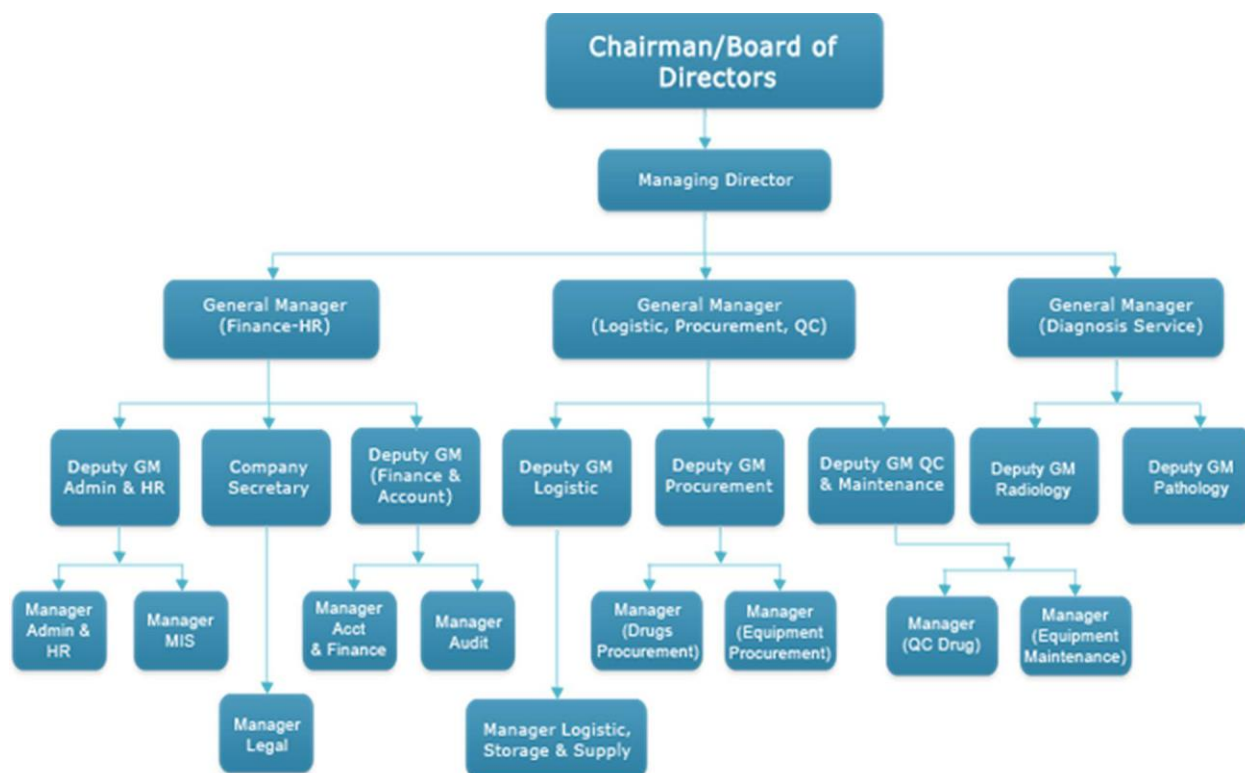
Account Branch – Payment of Bills, Preparation of Accounts.
