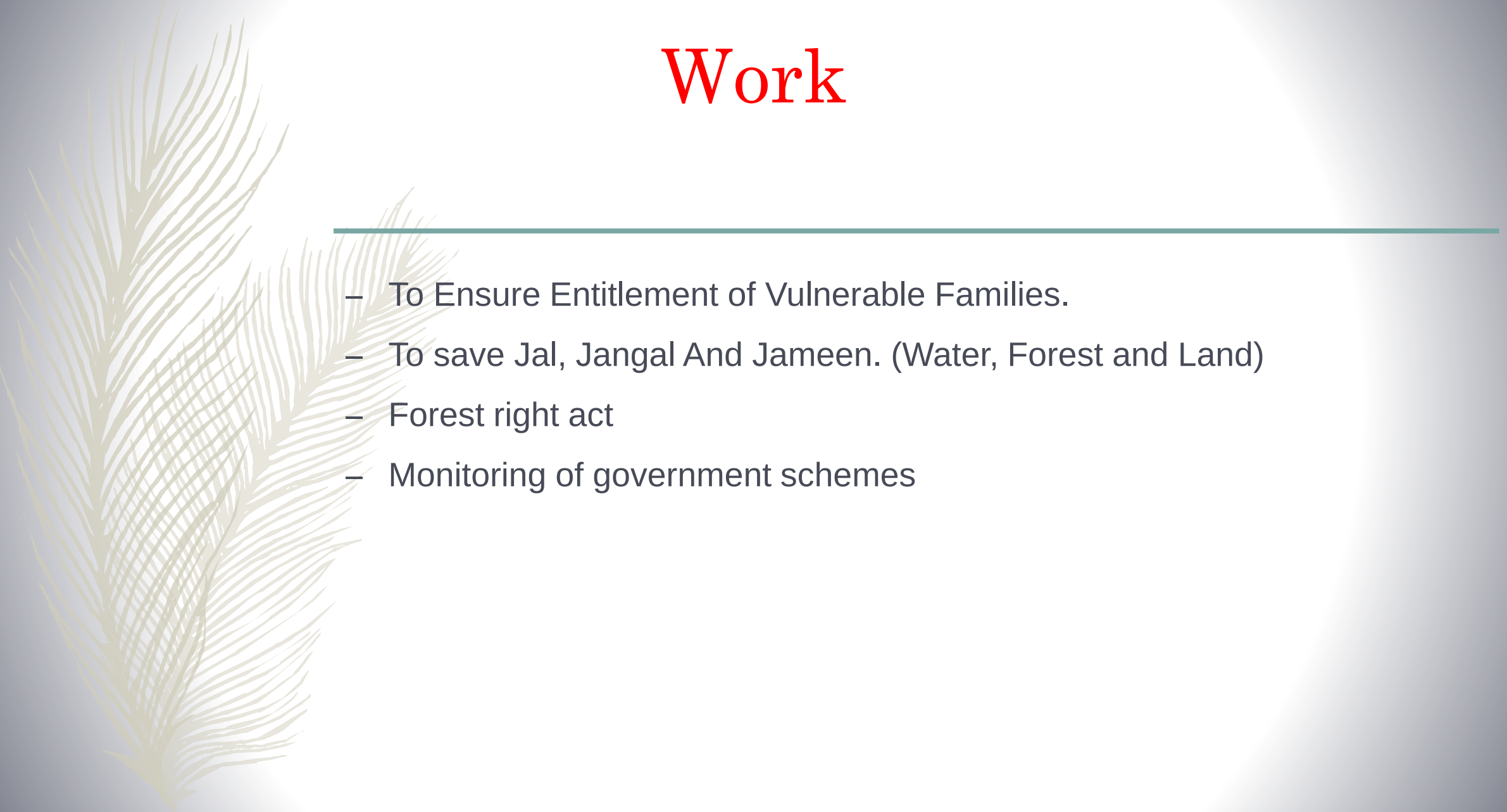
Introduction

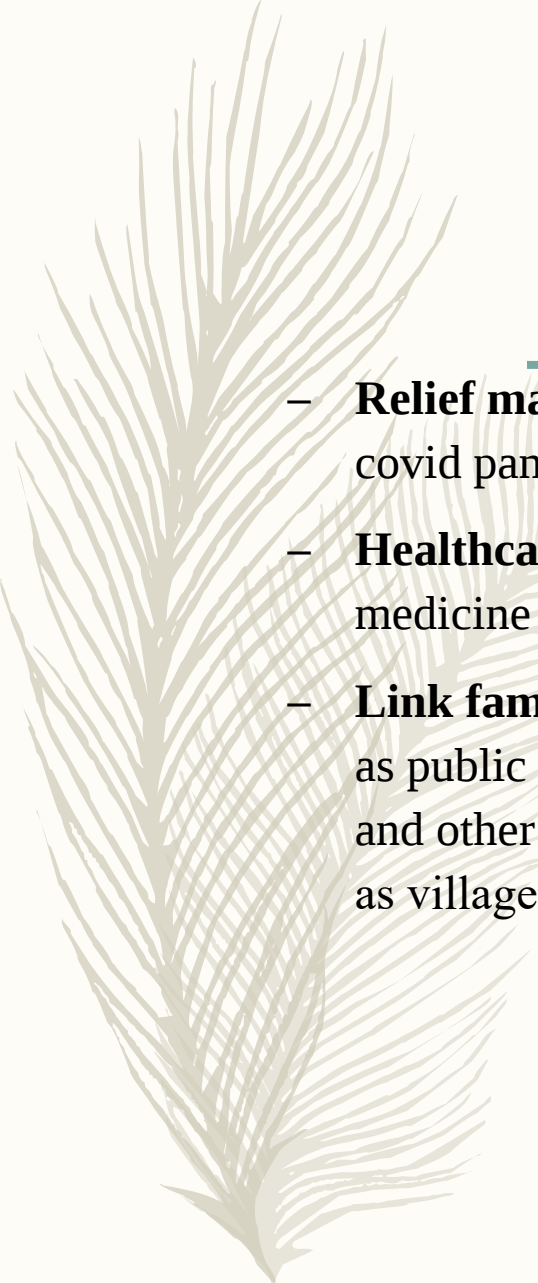
- Primary school – school has been close for the last two years the children's do not remembers their lessons. Online teaching is difficult in village.

- Distribution of dry ration



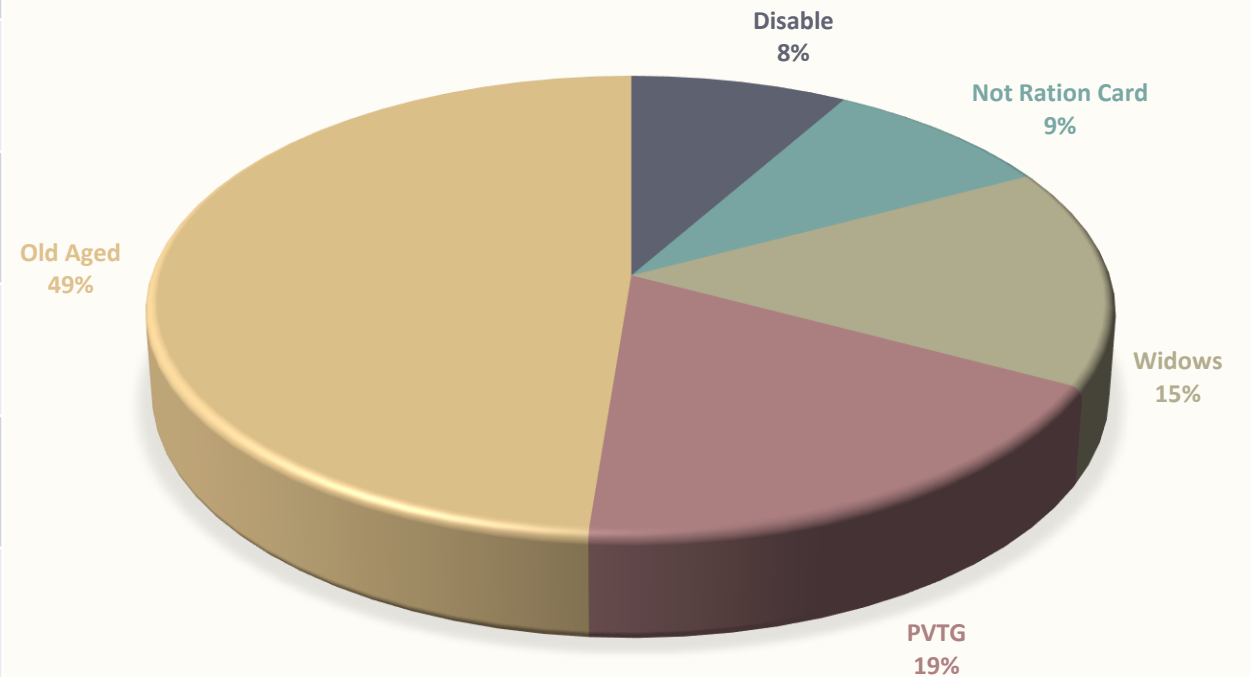
Key learning Performance
